2. HAZARDS IDENTIFICATION

3. COMPOSITION / INFORMATION ON INGREDIENTS

Scope. This sheet covers the 4 fl oz direct-spray formulation: **Golf Clean 4 oz Direct** and **Athletic Clean 4 oz Direct**. It does **not** cover the foaming formulation, which has its own Safety Data Sheet.

Mixture: purified water and a surfactant concentrate.

4. FIRST-AID MEASURES

- **General:** No special measures required. Move the affected person to fresh air. Avoid contact with eyes.

10. STABILITY AND REACTIVITY

- **Reactivity / chemical stability:** Stable under normal conditions.
- **Hazardous reactions:** None known.
- **Conditions to avoid:** Extreme temperatures, freezing.
- **Incompatible materials:** Do not mix with bleach (hypochlorite) or other cleaning products.
- **Hazardous decomposition products:** None known.

11. TOXICOLOGICAL INFORMATION

- **Acute toxicity:** Based on available data, the classification criteria are not met. Concentrate ATE: LD50 oral 12,837 mg/kg; the diluted product is of lower toxicity.

- **Skin corrosion/irritation; serious eye damage/irritation:** Classification criteria not met.
- **Germ cell mutagenicity, carcinogenicity, reproductive toxicity, STOT (single and repeated), aspiration hazard:** Classification criteria not met.
- **Likely routes of exposure:** Dermal and ocular contact.
